## **Statement of reasons for seeking extension**

Consent to extend the period of the administration was sought for the following reasons:

1. The initial administration period of 12 months was insufficient for the Joint Administrators to achieve the purpose of the administration, as stated in the joint administrators' proposals;
2. Settlement of the trading suppliers' costs have not been concluded. In particular, the Joint Administrators are dealing with utility companies and councils in order to obtain correct invoices for the trading period;
3. Further time is required to review and adjudicate upon the preferential creditor claims and distribute to preferential creditors accordingly;
4. Further time is needed to deal with employment tribunal claims received;
5. Further time is required to deal with and conclude VAT matters;
6. After all of the above matters are completed, we must deal with closure matters including drafting and issuing the final progress report, closure of our internal systems, and removal of the Administrators' bond.
