- In the case of Security Realisations Limited, C.L.C Realisations Limited, PTR Realisations Limited, PRL Realisations 1 Limited, PEG 1 Realisations Limited and SGHW Realisations Limited we are finalising the Licence to Occupy in place and facilitating the assignment of the final leases to the Purchaser.
- In the case of C.L.C Realisations Limited, PTR Realisations Limited, PRL Realisations 1 Limited and Cordant Technical Limited to adjudicate creditor claims in order to declare and pay the Prescribed Part to unsecured creditors.
- A move to Creditors Voluntary Liquidation (in accordance with Paragraph 83 of Schedule B1 to the Insolvency Act 1986) is not possible, as there are insufficient funds available for a distribution to be made to the unsecured creditors of the Company other than via the prescribed part.
