Tomlinsons Dairies Limited - In Administration (the Company)

Further to my letter dated 12 September 2022 notifying creditors of the application to further extend the period of the administration, I write to advise that the court granted a further extension to the administration period, which will now expire on 13 October 2023.

A further extension was requested as certain matters remain outstanding which require additional time to conclude. The main outstanding matter is the receipt of monies from HMRC in respect of tax and VAT refunds. Due to ongoing delays within HMRC, the full amount of the tax and VAT refunds are yet to be received. These funds are required before the prescribed part dividend can be distributed, as they make up a proportion of the monies to be distributed to creditors via the prescribed part.

Once the outstanding monies have been received from HMRC, the Joint Administrators will be required to:

- pay the outstanding costs and expenses of the administration;
- agree certain creditor claims in the administration and make final distributions;
- deal with statutory matters and duties including the issue of VAT deregistration form;
- complete all other administrative matters in order to finalise and close the administration.
