Statement of reasons why an extension was sought:

The initial administration period of 12 months is insufficient for the Joint Administrators to achieve the purpose of the administration, as stated in their proposals. We have not yet completed the administration of the company, and further time is required to address the following matters including, but not limited to:

- Realise remaining property;
- Conclude the B&M and Pepco options, and the licence to occupy, in respect of the company's leasehold interests;
- Finalise matters in relation to the trading period;
- Progress and conclude our investigations and claims work;
- Continue to develop and execute an appropriate strategy to manage tribunal claims and liaise with redundant team members to ascertain their unsecured claims;
- Deal with and conclude final tax and VAT position;
- Review and adjudicate upon the preferential creditor claims and distribute to preferential creditors accordingly;
- Review and adjudicate upon the unsecured creditor claims and prepare to distribute to unsecured creditors accordingly;
- Determine the most appropriate means to return funds to unsecured creditors, including the most appropriate way to exit the administration; and
- After all of the above matters are completed, deal with closure matters including drafting and issuing the final progress report, closure of our internal systems, and removal of the Administrators' bond.
